Privacy Policy & Terms of Use Agreement for Hotel Agents

You have indicated your intent to enroll Guests in The Guestbook service as agent for a Participating Property, which role shall be referred to herein as a "Hotel Agent," via the Hotel Agent sign-up page. To confirm your status as a Hotel Agent, you must acknowledge and accept the standard Guestbook Rewards, Inc. Terms of Use Agreement and Privacy Policy, as well as the following provisions for Hotel Agents we have added to the Terms of Use Agreement and Privacy Policy.

A. Privacy Policy Addendum: Hotel Agent

1. The following is added at the end of Section 2. SHARING OF YOUR INFORMATION:

"Hotel Agent: If you are a Hotel Agent, we may share your personally identifiable information with the Participating Property for which you act as a Hotel Agent for any period of time for which you are or were self-identified as a Hotel Agent. This personally identifiable information may include the email address(es) and name on your account with The Guestbook, the period(s) of time during which you were self-identified as a Hotel Agent, and the enrollment data and usage statistics of the Guests whom you enroll. You may disable your status as a Hotel Agent at any time in the "My Account" settings."

B. Terms of Use Agreement Addendum: Hotel Agent

1. The following is added following Section 3. Earning Loyalty Rewards:

"3A. Earning Hotel Agent Rewards

"If you have signed up to enroll Guests in The Guestbook service as agent for a Participating Property, which role shall be referred to herein as a "Hotel Agent," you are eligible to participate in the Hotel Agent Incentive Program, which provides Hotel Agent Rewards to Hotel Agents who provide qualified member enrollments to The Guestbook. As Hotel Agent, you are not agent of the Service or Guestbook Rewards, Inc. During any period for which: i) you are self-identified as a Hotel Agent; ii) the Participating Property for which you are enrolling Guests in the Service in its sole discretion permits you to participate in the Hotel Agent Incentive Program; and iii) The Guestbook determines in its sole discretion to provide Hotel Agent Rewards, you may earn Hotel Agent Rewards. A Hotel Agent Reward is earned when all of the following are satisfied: i) you enter a valid Guest's e-mail in the Participating Property's Hotel Agent Sign-Up page for a Guest who does not already have an account with The Guestbook; ii) you enter one of your e-mail addresses associated with your account with The Guestbook on the Participating Property's Agent Sign-Up page; iii) the enrolled Guest confirms a new Account with The Guestbook; and iv) the enrolled Guest submits an Eligible Bill to The Guestbook for the Participating Property for which you are Hotel Agent. Hotel Agent Rewards you earn are subject to the terms and conditions governing Loyalty Rewards."

The following is added following Section 4. Redeeming Loyalty Rewards:

"4A. Redeeming Hotel Agent Rewards

"As a Hotel Agent you may redeem Hotel Agent Rewards subject to the same terms and conditions and in the same manner as specified in Section 4. For redeeming Loyalty Rewards, and subject to the following additional conditions: i) Hotel Agent Rewards may not be redeemed in an amount less than US \$10 or its currency equivalent as is specified in your account profile/settings; and ii) Hotel Agent Rewards may be redeemed no more than once per day.

This agreement was last modified on June 16th, 2015
